



On Monday, 06 November, 2023, Indian equity markets continued their gaining momentum for third consecutive day and ended trade near day's highest level. On Tuesday, 07 November 2023, Indian equity benchmarks ended flat with negative bias. Markets witnessed dull trade throughout the day tracking weakness in Asian counterparts. Sensex lost 16.29 points or 0.03% to settle at 64,942.40. On Wednesday, 08 November, 2023, markets witnessed equity throughout the day and ended session with minor gains. Traders were on sidelines ahead of IIP and CPI data. Sensex was up by 33.21 points or 0.05% to settle at 64,975.61. On Thursday, 09 November, 2023, Indian equity benchmarks made slightly positive start as crude oil prices softened overnight. Sensex was down 143.41 points or 0.22% to settle at 64,832.20. On Friday, 10 November, the S&P BSE Sensex was up 72.48 points or 0.11% to 64,904.68.




#### **NEWS BULLETIN**

- **REC** has signed Memorandum of Understanding (MoU) with RailTel Corporation of India to extend financial assistance up to Rs 30,000 crore for infrastructure projects to be executed by RailTel in next 5 years.
- **EaseMyTrip** has launched its first offline franchise retail store in Pune, Maharashtra. This is a strategic move aligned with the brand's expansion plans through its franchise model.
- Marksans Pharma's wholly owned subsidiary -- Time-Cap Laboratories, Inc. has received Establishment Inspection Report (EIR) from US Food & Drugs Administration (USFDA) for audit conducted in October 2023.
- **Ashok Leyland** has received approval from Board of Directors for an investment of Rs 1200 crore in Switch Mobility as equity through its holding company Optare PLC UK.
- **Zee Entertainment Enterprises** has reported 12.08% fall in its net profit at Rs 155.24 crore for the quarter under review as compared to Rs 176.56 crore for the same quarter in the previous year.
