खरीफ फसलों के रकबे में आई गिरावट

बारिश की रफ्तार बढ़ने का असर खरीफ की फसलों की बोआई पर देखने को मिल रहा है। इस महीने के शुरुआत में जहां इन फसलों का रकबा 20 फीसदी कम था, वह अब घटकर करीब 16 फीसदी रह गया है। हालांकि चिंता की बात यह है कि इस माह शुरुआती दौर में अच्छी बारिश के बाद अब मॉनसून की रफ्तार थम गई है।

मौसम विभाग के अनुसार पूर्वानुमान के अनुसार अगले 6 से 7 दिनों तक मॉनसून के ज्यादा सक्रिय होने की संभावना नहीं है। इस सीजन की प्रमुख फसल धान से लेकर दलहन, तिलहन, मोटे अनाज, व कपास के रकबा में गिरावट दर्ज की गई है।
